

## Dorset Adventure Park School / Group ACKNOWLEDGEMENT OF RISK

### Acknowledgement of Risk

Participation in activities at Dorset Adventure Park involves inherent risks, including physical injury. These activities are physically demanding and may include contact with other participants, natural and man-made obstacles, unpredictable environmental conditions and can cause feeling of discomfort or fear. We ensure that all activities are conducted with the highest safety standards, but it is important to be aware of the potential risks.

The Mud Trail is a woodland assault course on undulating ground with natural obstacles in addition to the obstacles constructed by Dorset Waterpark Ltd. The Waterpark is an inflatable assault course spread over multiple lakes. Participation involves swimming, swinging, slides and jumping from height.

### Assumption of Risks

By allowing the children in your care to participate, you acknowledge the inherent risks involved in all activities at Dorset Adventure Park. These risks include, but are not limited to, collisions, obstacles, weather-related hazards, and natural hazards. Injuries may range from minor to severe. Participation is physically demanding, and accidental injury is possible.

### Limitation of Liability

I waive, release, and discharge Dorset Waterpark Limited from any claims arising from participation in all activities at Dorset Adventure Park, except for liability that cannot be excluded under applicable law. In the unlikely event of an accident, loss, or damage to personal effects, the Company will not be liable for any direct or indirect loss, damage, or injury (except for death or personal injury caused by the Company's negligence). Nothing in this disclaimer limits or excludes liability for death or personal injury resulting from negligence or any liability that cannot be excluded under applicable law.

### Restrictions

Waterpark participants must be aged 6 or over and be more than 100cm tall. Participants must be able to swim 25 metres unaided and be confident in the water. Children under 8 must be supervised by an adult on a 1:3 ratio.

The nature of the Mud Trail may result in damage to clothing. It is very important that all participants wear footwear at all times on the trail. Long sleeves and long trousers are recommended. When using the Mud Trail, if we do not think individual children, or the whole group, are capable of an obstacle, we will not allow them to access the obstacle in question.

Before participating in either activity it's very important that we know of any pre-existing health issues which may impact on your children's participation such as Back/Neck Injuries, Diabetes, Epilepsy, Respiratory, Cardiovascular, Psychological, past dislocation injuries or other health considerations affecting a participant's performance. Please see our website for full list of medical recommendations and exclusions. You must inform a member of staff before your session if any of your children have any pre-existing health issues. If appropriate, inhalers and autoinjector must be with your children on their session.

For safety reasons, the maximum weight for an individual on either course is 115 kg/18 stone.

**Participants and Parents/Guardians of Minors:** Please read carefully. This waiver affects your legal rights. By agreeing to this waiver, you consent to the minor's participation under your supervision or that of an accompanying adult. You assume full responsibility for the minor's compliance with all rules and safety instructions.

**Activities:** The Mud Trail is a woodland assault course on undulating ground with natural obstacles in addition to the obstacles constructed by Dorset Waterpark Ltd. The Waterpark is an inflatable assault course spread over multiple lakes that also includes obstacles between trees. Participation involves swimming, swinging, slides and jumping from height. Axe Throwing involves throwing specially designed axes at a designated target from a safe distance within a controlled environment.

**Assumption of Risks:** Participation in all activities at Dorset Adventure Park involves inherent risks, including physical injury. These activities are physically demanding and may include contact with other participants, natural and man-made obstacles, and unpredictable environmental conditions. I agree to undertake the activities at my own risk and will take reasonable care during activities, understanding they include natural and constructed obstacles.

**Acknowledgment of Risks:** I acknowledge the inherent risks of participating in all activities at Dorset Adventure Park, which include but are not limited to: collisions, obstacles, weather-related hazards, and natural hazards. Injuries may range from minor to catastrophic. I understand that participation is physically demanding and accidental injury is possible.

**Limitation of Liability:** I waive, release, and discharge Dorset Waterpark Limited from any claims arising from participation in all activities at Dorset Adventure Park, except for liability that cannot be excluded under applicable law. **Health and Safety:** I will consult with a doctor before participating and will notify staff of any unsafe conditions. I am responsible for the condition of any equipment I bring. I and the children in my care will follow all instructions given on signs or verbally by staff. I will inform the Company of any pre-existing health issues that may impact participation, such as back/neck injuries, diabetes, epilepsy, respiratory, cardiovascular, psychological conditions, past dislocation injuries, pregnancy, or other health considerations (see medical restrictions on website). To the best of my knowledge, I and the children under my supervision do not have any medical conditions that might increase the risk of injury. I agree to take responsibility for my own and others' health, well-being, and property in relation to the use of all activities at Dorset Adventure Park.

**Photographs and CCTV:** I consent to photographs and CCTV recordings of me and minors in my care for marketing and security purposes.
